**'big marijuana claims vs the science**

May 21st, 2020 - our currently legal drugs alcohol and tobacco provide a good example since both youth and adults use them far more frequently than illegal drugs according to recent surveys alcohol use is used by 52 of americans and tobacco is used by 27 of americans but marijuana is used by only 8 of americans'

May 23rd, 2020 - the opioid epidemic also known as the opioid crisis refers to the extensive overuse of opioid medications both from medical prescriptions and from illegal sources the epidemic began in the

*united states in the late 1990s when opioids were increasingly prescribed for pain management and resulted in a rise in overall opioid use throughout subsequent years'*

May 21st, 2020 - population based estimates of substance use patterns have been regularly reported now for several decades concerns with the quality of the survey methodologies employed to produce those estimates date back almost as far those concerns have led to a considerable body of research specifically focused on understanding the nature and consequences of survey based errors in substance use epidemiology'

May 20th, 2020 - by using data from the national survey on drug use and health we find that the legalization of recreational marijuana in wa induced an increase in the consumption of cannabis of about 2 5 percentage points off a base level of about 10 a decrease in the consumption of other drugs of about 0 5 points off a base level of about 4 and a decrease in the consumption of both ordinary alcohol'
